REGULATIONS.

1. ENTRY. Entry forms must be obtained from an ORPA club secretary. Entry form to be sent to Secretary of Meeting by 1st May 2010 with cheque, payable to SMX club, for £70 incl. VAT to cover both days.
2. There is no personal accident cover in the entry fee. It is recommended that CICA cover is taken out. CICA representative attends most meetings – see TMX advert for Telephone No
3. QUALIFICATION. Competitors must have competed with an ORPA club.
4. CLASSES. There will be classes for 125; 250 2 Stroke; 500 2 Stroke; Open 4 Stroke; 250 4 Stroke; Over 40s; Over 50s; Over 60's; Ladies, Twinshocks. Only one class per competitor.
If necessary, qualifying heats will be run.
5. RACES. There will be three championship races run each day. All will count towards overall results.
6. Riders riding in the pits will be instantly banned from the meeting.
7. Minimum two laps practice per rider.
8. Trophies will be awarded down to sixth place in all groups.
9. Spectators are forbidden to cross the track at any time. The infield is a prohibited area. Riders may visit the infield only with the Clerk of the Course's permission.
10. Fourstrokes must have standard silencers or sanctioned noise inserts or 94 Db silencers.
11. It is an offence to enter this event under the age of sixteen. A parent or guardian countersigning could be liable for prosecution in the criminal courts.

INDEMNIFICATIONS.
